you in 5th Year? - Fifth year or repeat fifth year candidates may not enter for any subject in the Leaving Certificate examinations in 2021.

You may not enter for any Leaving Certificate examinations in 2021 if you are an external candidate following a two year Leaving Certificate programme (5th and 6th year) and are currently in 5th year/year 1 of that programme. The SEC is aware that some external candidates studying in private colleges have been advised that they can sit a small number of examinations in fifth year (for example, to meet matriculation requirements) with the intention of taking the remainder of their subjects in 6th year. This is incorrect and the SEC wishes to advise any candidate in this situation that they may not enter for the Leaving Certificate in 2021. Candidates are asked to confirm that they understand the conditions of eligibility for entering the examinations which includes this particular requirement. The penalty for breaching this condition of entry includes removal from the entry registrar or withholding examination results.
