### THE ECONOMISTS' CORNER

The lights dazzled our eyes while the warmth of carol songs sweetened our hearts - another year of Christmas has come. As a boring economist, I want to know whether giving Christmas presents is a waste of resources. Imagine Santa gives you a jumper worth \$100 which you only value at \$30. The welfare loss is \$70 as Santa has spent \$70 more than the jumper is worth to you. The deadweight loss is a sign that the gift-givers are not very good at predicting what gifts the receivers will appreciate.

A survey was conducted by Waldfogel (1993): it estimates averagely in-kind gifts lose 10-33% of their value compared to cash - resulting in welfare losses. So, should Santa start putting bundles of cash inside the socks? The motivation for gift-giving is altruism and love. By giving cash, Santa seems to be impersonal and indifferent, non-monetary gifts show care, as the receiver wants the donor to spend time thinking and searching for an appropriate gift. Sticking to the wish lists can solve the potential deadweight loss problems. However, this might increase the financial pressure if the presents on the wish list are not humble. But who cares? According to the Forbes, Santa ranks no.1 and has infinite wealth, these costs make no difference to him. HOHOHO
